RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, RONNIE T. DADIVAS, TO ENTER INTO AND SIGN FOR AND ON BEHALF OF THE CITY GOVERNMENT OF ROXAS THE MEMORANDUM OF AGREEMENT (MOA) WITH THE CAPIZ PROVINCIAL GOVERNMENT, RELATIVE TO THE FINANCIAL ASSISTANCE FOR THE CONDUCT OF ACTIVITIES FOR CAPIZTAHAN 2026.

WHEREAS, in his 1st Indorsement dated February 20, 2026, the City Mayor requested and favorably endorsed to the Honorable Sanggunian the attached letter of the City Tourism Office regarding Capiztahan 2026 along with attached draft MOA with the intention of requesting for authority to sign and on behalf of the city government of Roxas City for appropriate action;

WHEREAS, the Capiztahan is the province-wide celebration of the Founding Anniversary of the Civil Government of the Province of Capiz under the American regime, and is the culmination of the province's celebration of its culture, tourism, arts and aqua-agricultural bounty;

WHEREAS, the City Government of Roxas will participate in the Maragtas sang Capisnon: Cultural Parade and Performances, Saot Capiz: Capisnon Folkdance Competition, Hangaway kag Lin-ay sang Capiz, Tagbuanany sang Maragtas (Foot Parade and Fluvial Parade), Punsyon sang Kabanwahanan, and Bugal sang Capiz to be held as part of the celebration of Capiztahan 2026;

WHEREAS, the participation of the City Government of Roxas will contribute to the grandeur and significance of the Capiztahan 2026 and therefore vital to its success;

WHEREAS, Section 455 (v) (I) (vi) of the Local Government Code of 1991, provides that the City Mayor shall represent the City in all business transactions and sign in, its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;
