RESOLUTION NO. 044 - 2026

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, RONNIE T. DADIVAS, TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE CITY OF ROXAS THE DATA TURNOVER AGREEMENT WITH THE PHILIPPINE STATISTICS AUTHORITY RELATIVE TO THE 2024 COMMUNITY-BASED MONITORING SYSTEM (CBMS) DATA INTENDED FOR LGU'S EVIDENCE-BASED PROJECT DEVELOPMENT AND PROGRAM IMPLEMENTATION.

WHEREAS, in his letter dated March 9, 2026, the City Mayor requested authority to enter into and sign for and in behalf of the City of Roxas the Data Turnover Agreement with the Philippine Statistics Authority relative to the 2024 Community-Based Monitoring System (CBMS) data intended for LGU's evidence-based project development and program implementation;

WHEREAS, Philippine Statistics Authority as the lead agency in the implementation of RA 11315 shall undertake measures to ensure the integrity and safety of the gathered information against unnecessary leakage and access by unauthorized persons;

WHEREAS, the Community-Based Monitoring System (CBMS) was established and instituted in every city and municipality as an economic and social tool for the formulation and implementation of poverty alleviation and development programs that are specific, targeted, and responsive to the basic needs of each sector of the community pursuant to Republic Act No. 11315 or the Community-Based Monitoring System Act;

WHEREAS, pursuant to PSA Board Resolution No. 04, Series of 2024, a simultaneous conduct of the 2024 Census of Population (POPCEN) and CBMS shall be conducted from July to September 2024 to update the mid-decade inventory of the population of the entire Philippines and update the social registries of national government agencies and local government units for evidence-based project development and program implementation;

WHEREAS, RA 11315 provides that the cities and municipalities can maintain their CBMS database for local-level planning and program implementation, and the PSA shall receive and store all aggregated data gathered by the cities and municipalities to create a national CBMS databank;

WHEREAS, Section 455(1)(vi) of the Local Government Code of 1991, provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and, such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;


