RESOLUTION APPROVING THE APPLICATION FOR FINAL APPROVAL AND DEVELOPMENT PERMIT OF ASCENSION GARDENS MEMORIAL PARK/ CEMETERY PROJECT WITH A DEVELOPMENT AREA OF 36,597 SQ.M., ESTABLISHED ON LOTS 1-I-2, 1-I-6, 1-I-9 AND 1-I-10, LOCATED AT BARANGAYS DINGINAN AND SIBAGUAN, ROXAS CITY, OWNED AND DEVELOPED BY SACRED HEART OF JESUS DEVELOPMENT CORPORATION.

WHEREAS, in his letter dated February 3, 2026, the City Mayor forwarded to the Honorable Sangguniang Panlungsod of Roxas City the letter of Engr. Rebecca Y. Andrade, Acting Zoning Administrator, relative to the application for Final Approval and Development Permit of Ascension Gardens Memorial Park/ Cemetery Project with a development area of 36,597 sq.m. located at Barangays Dinginan and Sibaguan, Roxas City, for appropriate action;
