RESOLUTION NO. 050 - 2026

RESOLUTION RESPECTFULLY REQUESTING THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) FOR FUNDING ASSISTANCE UNDER THE PAGCOR SCHOOL BUILDING PROGRAM TO FUND THE CONSTRUCTION OF A SCHOOL BUILDING AT PRESIDENT MANUEL ROXAS MEMORIAL INTEGRATED SCHOOL – SOUTH, ROXAS CITY, CAPIZ.

WHEREAS, in a letter dated March 23, 2026, the Honorable City Mayor, Ronnie T. Dadivas, requested the passage of a resolution requesting the Philippine Amusement and Gaming Corporation (PAGCOR) for funding assistance to fund the construction of a school building at President Manuel Roxas Memorial Integrated School – South, under the PAGCOR School building Program;

WHEREAS, on March 19, 2026, the city government was informed via electronic mail the selection of Roxas City as one of the beneficiaries of PAGCOR's School Building Program;

WHEREAS, the Philippine Amusement and Gaming Corporation (PAGCOR) school building program is a major initiative that funds, constructs, and turns over multi-storey, durable classrooms to public schools nationwide to alleviate shortages, particularly in far-flung areas. These projects provide larger classrooms (7x9 meters) and storage rooms;

WHEREAS, the City Government of Roxas continues to support initiatives that strengthen the delivery of basic education services in partnership with national government agencies;

WHEREAS, the City Government of Roxas acknowledges the steadfast commitment of PAGCOR, in partnership with Department of Education (DepEd), in addressing classroom shortages of public school facilities nationwide;

WHEREAS, the Sanggunian finds it proper and appropriate to endorse the request of the Roxas City Government to the Philippine Amusement and Gaming Corporation (PAGCOR) for funding assistance;

NOW THEREFORE, on motion presented by Hon. John Paul J. Arcenas, unanimously seconded, it was
