RESOLUTION APPROVING AND ADOPTING CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 04, SERIES OF 2026, ENTITLED, “A RESOLUTION APPROVING THE INCLUSION IN THE ANNUAL INVESTMENT PROGRAM OF THE CITY GOVERNMENT OF ROXAS OF VARIOUS PRIORITY PROGRAMS, PROJECTS AND ACTIVITIES TO BE FUNDED FROM EXTERNAL SOURCES IN THE TOTAL AMOUNT OF THREE HUNDRED EIGHTY-NINE MILLION PESOS (P389,000,000.00).

WHEREAS, in his 1ST Indorsement dated March 19, 2026, the Honorable City Mayor, Ronnie T. Dadvivas, endorsed to the Sangguniang Panlungsod of Roxas City, City Development Council (CDC) Resolution No. 04 -2026 for appropriate and urgent action;

WHEREAS, Section 106 and Section 109 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates the Local Development Council to formulate and recommend to the Sanggunian the Annual Investment Program for approval;

WHEREAS, the City Government of Roxas continuously coordinates with national government agencies and other funding institutions to secure financial assistance and grants in support of local development initiatives;

WHEREAS, several priority programs, projects and activities have been identified for implementation in the City of Roxas which are proposed to be funded through external sources including national government programs, grants and financial assistance;

WHEREAS, the inclusion of these programs, projects and activities in the Annual Investment Program will enable the City Government to formally pursue finding support and ensure alignment with the City's development priorities;

WHEREAS, after thorough presentation and deliberation of City Development Council Resolution No. 04-2026, the members of the Sangguniang Panlungsod of this City found the proposal to be meritorious and beneficial to the interest and general welfare of the city residents;

WHEREAS, a copy of City Development Council Resolution No. 04 -2026 is hereto attached and forms an integral part of this Resolution;
