RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, RONNIE T. DADIVAS, TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE CITY OF ROXAS, THE MEMORANDUM OF AGREEMENT (MOA) WITH WESTY TRANSPORTER, REPRESENTED BY ITS CHAIRMAN/MANAGING HEAD, MR. GARRY HERMOSILLA, AND THE MAYA MEDWASTE CORPORATION, REPRESENTED BY ITS MARKETING AND SALES MANAGER, MS. CRISTY PARRENO. RELATIVE TO THE PROPER TRANSPORTATION AND TREATMENT OF HAZARDOUS WASTES GENERATED BY THE CITY.

WHEREAS, in his letter dated March 19, 2026, the City Mayor requested for the passage of a resolution authorizing him to enter and to sign, for and in behalf of the City of Roxas the Memorandum of Agreement (MOA) with Westy Transporter, represented by its Chairman/Managing Head, Mr. Garry Hermosilla, and the Maya Medwaste Corporation, represented by its Marketing and Sales Manager, Ms. Cristy Parreno. relative to the proper transportation and treatment of hazardous wastes generated by the city;

WHEREAS, Westy Transporter is a qualified and duly accredited Hazardous Industrial Waste Transporter with Transporter Registration Certificate No. OL-TP-R6-04-000237, has offered to transport hazardous waste from the place of origin to the place of TSD Facility;

WHEREAS, Maya Medwaste Corporation, is a qualified and duly accredited Hazardous Industrial Waste Treater with TSD Registration Certificate No. DENR OL-T-R3-14-002212, has offered to treat the hazardous waste;

WHEREAS, Westy Transporter and Maya Medwaste Corporation warrant their compliance to Republic Act No. 6969, as well as other environmental laws, such as but not limited to Presidential Decree No. 984 (Pollution Control Law), Presidential Decree No. 1586 (Environmental Impact Assessment System Law), Republic Act No. 8749 (Clean Air Act) and Republic Act No. 9003 (Ecological Solid Waste Management Act), and their respective and Implementing Rules and Regulations;

WHEREAS, Hazardous Waste Management is a pervasive problem and a looming crisis in the Philippines, where the proper management, transport and final disposal of these pathological and infectious wastes has been an issue;

WHEREAS, Section 455(1)(vi) of the Local Government Code of 1991, provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and, such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;
